

AVIANCA GROUP INTERNATIONAL LIMITED REPORTS JUNE 2025 TRAFFIC

Bogota, Colombia – July 11, 2025. Traffic Report. Avianca Group International Limited affiliated passenger airlines ("AGIL" or "the Group") transported 3.1 million passengers in June 2025; a 2.4% decrease when compared to June 2024. AGIL's total capacity deployment increased by 12.9%, to 6.1 billion ASKs from 5.4 billion in the same period of 2024. Total RPKs for the period increased by 11.6% to reach 4.9 billion in June 2025, from 4.4 billion in June 2024. Departures in June 2025 increased by 1.4% to 21.7 thousand from 21.4 thousand in the same period of 2024.

Noteworthy Results - Passenger Segment

- International operation ASKs for June 2025 increased by 18.8% year-on-year. June 2025 RPKs increased by 16.8%, with an 80.1% Load Factor. Departures for June 2025 increased by 17.3% year-on-year.
- Domestic ASKs for June 2025 decreased by 12.3% year-on-year, with a 10.4% decrease in RPKs and a Load Factor of 84.6%. Departures decreased by 9.8% year-on-year.

Noteworthy Results - Cargo Segment

 Cargo ATKs in June 2025 increased by 8.0% year-on-year, with a 6.0% RTKs increase as compared to June 2024 and a Load Factor of 61.1%. Departures in June 2025 decreased by 11.1% year-on-year.

Glossary

Available Seats Kilometer (ASK).

Available seat kilometers represent aircraft seating capacity multiplied by the number of kilometers the seats are flown.

Revenue Passenger Kilometer (RPK).

Revenue passenger kilometers represent the number of kilometers flown by revenue passengers.

Available Ton Kilometer (ATK).

One Tons carried one kilometer (whether occupied or not).

Revenue Ton Kilometer (RTK).

Revenue ton kilometers represents the total cargo tonnage transported multiplied by the number of kilometers the cargo is flown.

Percentage Point (PP).

The difference between two percentages is termed as percentage point. Percentage point is used to show the changes in an indicator with respect to its previous standings. One percentage point is also equal to 100 basis points.
