

AVIANCA GROUP INTERNATIONAL LIMITED

REPORTS SEPTEMBER 2025 TRAFFIC

Bogota, Colombia – October 10, 2025. Traffic Report. Avianca Group International Limited affiliated passenger airlines (“AGIL” or “the Group”) transported 2.9 million passengers in September 2025; a 0.3% decrease when compared to September 2024. AGIL’s total capacity deployment increased by 5.7%, to 5.5 billion ASKs from 5.2 billion in the same period of 2024. Total RPKs for the period increased by 5.8% to reach 4.4 billion in September 2025, from 4.2 billion in September 2024. Departures in September 2025 increased by 2.3% to 20.6 thousand from 20.2 thousand in the same period of 2024.

Noteworthy Results - Passenger Segment

- International operation ASKs for September 2025 increased by 8.5% year-on-year. September 2025 RPKs increased by 8.1%, with an 80.4% Load Factor. Departures for September 2025 increased by 13.1% year-on-year.
- Domestic ASKs for September 2025 decreased by 6.3% year-on-year, with a 3.8% decrease in RPKs and a Load Factor of 83.2%. Departures decreased by 4.7% year-on-year.

Noteworthy Results - Cargo Segment

- Cargo ATKs in September 2025 increased by 10.3% year-on-year, with a 11.6% RTKs increase as compared to September 2024 and a Load Factor of 66.2%. Departures in September 2025 increased by 17.8% year-on-year.

Glossary

Available Seats Kilometer (ASK).

Available seat kilometers represent aircraft seating capacity multiplied by the number of kilometers the seats are flown.

Revenue Passenger Kilometer (RPK).

Revenue passenger kilometers represent the number of kilometers flown by revenue passengers.

Available Ton Kilometer (ATK).

One Tons carried one kilometer (whether occupied or not).

Revenue Ton Kilometer (RTK).

Revenue ton kilometers represents the total cargo tonnage transported multiplied by the number of kilometers the cargo is flown.

Percentage Point (PP).

The difference between two percentages is termed as percentage point. Percentage point is used to show the changes in an indicator with respect to its previous standings. One percentage point is also equal to 100 basis points.
