recipients with \$2,500, \$1,500 and \$1,000 respectively. Scholarships will be awarded based on financial need, academic achievement, and a two-page essay describing their view of the future of the chiropractic profession. To apply, chiropractic students may request the application materials from their college's financial aid office during the first part of the 2016 spring semester.
