

Perma-Fix Chief Operating Officer Awarded Southeast Compact Commission's 2007 Richard S. Hodes, M.D. Honor Lecture Award

Hodes, M.D. Honor Lecture Award. The award, to be presented at the Waste Management Symposium held in Tucson, Arizona, in February 2007, recognizes innovation in the nuclear industry.
