Perma-Fix Environmental Services Announces Win of Major Subcontract at the Department of Energy Hanford Site

ATLANTA, June 20 /PRNewswire-FirstCall/ -- Perma-Fix Environmental Services, Inc. (Nasdaq: PESI) ("Perma-Fix") today announced that it has been awarded a major subcontract through its East Tennessee Materials & Energy Corporation (M&EC) subsidiary for waste management and facility operations at the Department of Energy (DOE) Hanford, Washington Site. M&EC is a small business team member of the CH2M Hill Plateau Remediation Company (CHPRC) team led by CH2M Hill Constructors, Inc. that has been awarded the prime contract by the DOE for the Plateau Remediation Contract (PRC) at Hanford. The contract awarded to the CHPRC team is a cost-plus award-fee contract valued at approximately \$4.5 billion over ten years (a five-year base period with the option to extend it for another five years).

The Hanford PRC is part of the DOE's Hanford Central Plateau acquisition strategy that includes waste management and facility disposition on the Central Plateau. The Central Plateau is undergoing cleanup from decades of plutonium production in support of the nation's defense. M&EC will provide its waste facility operations expertise to support CHPRC in its mission to perform remediation, clean-up and waste management activities for DOE.

"We are extremely gratified that we are part of the CHPRC Team and look forward to assisting CH2M Hill and the DOE with the important clean-up mission at Hanford. This is our first major role working on a DOE site where we can bring our technologies and experience from over 20 years of complex waste management and generator services to bear. Our latest acquisition of our Perma-Fix Northwest treatment facility, located adjacent to the Hanford Site, will also provide us with local support for this contract," stated Perma-Fix Chief Executive Officer, Dr. Louis Centofanti. The CHPRC Team expects to start transition for the contract in early July 2008 and take over operations of the Central Plateau on October 1, 2008.

Perma-Fix is a national environmental services company, providing unique mixed waste and industrial waste management services. Perma-Fix has increased its focus on the nuclear services segment, which provides radioactive and mixed waste treatment services to hospitals, research laboratories and institutions, numerous federal agencies including DOE and the U.S. Department of Defense and nuclear utilities. The Industrial segment provides hazardous and non-hazardous waste treatment services for a diverse group of customers including Fortune 500 companies, numerous federal, state and local agencies and thousands of smaller clients.
