## Perma-Fix Awarded Radiological Support Contract

ATLANTA, GA -- (Marketwired) -- 04/09/14 -- **Perma-Fix Environmental Services, Inc.** (NASDAQ: PESI) today announced that it was awarded a contract valued at more than \$500,000 from Kemron Environmental Services to provide radiation safety, waste characterization, and brokerage services at the Safety Light Superfund Site, located in South Centre Township, PA.

"We look forward working closely with Kemron to advance the cleanup of this EPA Region III Superfund site and expect to commence operations this month," said Dr. Louis F. Centofanti, Chairman and Chief Executive Officer of Perma-Fix. "We are honored to be a part of this important mission by utilizing our proprietary technologies and expertise to support the clean-up of another one of our nation's Superfund sites."

The Safety Light Corp Superfund site is approximately 10 acres and bordered mostly by residential properties and the Susquehanna River. Past activities include the manufacturing of self-illuminated watches and instrument dials; smoke detectors; exit signs and other products containing radioactive materials (such as radium-226, strontium-90, cesium-137, and tritium).

The six month effort will be led by Project Radiation Safety Officer and Vietnam veteran Mark Shaffer, who brings 35 years of experience and has been with the company since 1997.
