
QuickLogic Corporation is committed to sustainable and responsible business practices.

QuickLogic continually invests in energy-efficient technologies to reduce its energy consumption and carbon emissions.






Product Sustainability

- LED lighting is used throughout the building and lights are turned off when not needed.






Electricity Usage - Decreasing






Race / Ethnicity / US Workforce
