

Southwest Airlines Appoints New Member to Board of Directors

Brooks joined Chili's in February 1978 as a manager at the company's original location on Greenville Avenue in Dallas. He rose through the ranks at Chili's, holding numerous positions including General Manager, Area Director, and Regional Vice President. Brooks was named President of the brand in 1994. In January 1999, he was promoted to President and COO of Brinker International. CEO and Chairman of the Board were added to his title and responsibilities in 2004.

Outside of the restaurant business and his community activities, Brooks spends his time with his wife of 32 years, Holly, and their two adult sons, Taylor and Kyle.
