

Shane McAnally, Singer, Songwriter, Producer to Host Exclusive New Series on SiriusXM's Volume Channel

'Songville' to debut on April 18 with special guest Kacey Musgraves

"Getting to sit down and have open conversation with artists, who are collaborators and friends, and break open the songwriting process inspires me and makes me even more proud to be a part of the songwriting community," said Shane McAnally. "With SiriusXM's *Songville*, we hope to share some of this love and pride with our fans."
