

# AVIANCA GROUP INTERNATIONAL LIMITED

## REPORTS OCTOBER 2025 TRAFFIC

**Bogota, Colombia – November 13, 2025. Traffic Report.** Avianca Group International Limited affiliated passenger airlines (“AGIL” or “the Group”) transported 3.0 million passengers in October 2025; a 0.6% decrease when compared to October 2024. AGIL’s total capacity deployment increased by 10.9%, to 5.7 billion ASKs from 5.1 billion in the same period of 2024. Total RPKs for the period increased by 12.1% to reach 4.6 billion in October 2025, from 4.1 billion in October 2024. Departures in October 2025 increased by 2.3% to 21.6 thousand from 21.1 thousand in the same period of 2024.

### Noteworthy Results - Passenger Segment

- International operation ASKs for October 2025 increased by 16.1% year-on-year. October 2025 RPKs increased by 17.3%, with an 81.4% Load Factor. Departures for October 2025 increased by 17.3% year-on-year.
- Domestic ASKs for October 2025 decreased by 9.1% year-on-year, with an 8.7% decrease in RPKs and a Load Factor of 80.4%. Departures decreased by 6.8% year-on-year.

## Operating Fleet

- The passenger operating fleet during October 2025 consisted of 15 Widebody and 134 Narrowbody aircraft. Furthermore, Wamos operating fleet comprised of 11 Widebody aircraft, and the Cargo operating fleet included 9 Freighters in the same period.

## Noteworthy Results - Cargo Segment

- Cargo ATKs in October 2025 increased by 29.4% year-on-year, with a 24.1% RTKs increase as compared to October 2024 and a Load Factor of 65.0%. Departures in October 2025 increased by 34.8% year-on-year.

## Glossary

### Available Seats Kilometer (ASK).

Available seat kilometers represent aircraft seating capacity multiplied by the number of kilometers the seats are flown.

### Revenue Passenger Kilometer (RPK).

Revenue passenger kilometers represent the number of kilometers flown by revenue passengers.

### Available Ton Kilometer (ATK).

One Tons carried one kilometer (whether occupied or not).

### Revenue Ton Kilometer (RTK).

Revenue ton kilometers represents the total cargo tonnage transported multiplied by the number of kilometers the cargo is flown.

### Percentage Point (PP).

The difference between two percentages is termed as percentage point. Percentage point is used to show the changes in an indicator with respect to its previous standings. One percentage point is also equal to 100 basis points.
