# **Atara Biotherapeutics' Collaborating Investigators' Abstract on T-Cell Therapy for EBV Lymphoma to be Presented at a Clinical Trials Plenary Session at the American Association for Cancer Research Annual Meeting 2015 is Now Available**

SOUTH SAN FRANCISCO, Calif., April 19, 2015 (GLOBE NEWSWIRE) -- Atara Biotherapeutics, Inc. (Nasdaq:ATRA), today announced that the abstract on cytotoxic T lymphocytes activated against Epstein-Barr Virus (EBV-CTL) that will be presented by its collaborating investigators at Memorial Sloan Kettering Cancer Center (MSK) at a Clinical Trials Plenary Session at the American Association for Cancer Research Annual Meeting (AACR) 2015 is now available. Clinical data on both the safety and efficacy of EBV-CTL in the treatment of patients with rituximab-refractory, EBV-associated lymphoproliferative disease (EBV-LPD) after allogeneic hematopoietic cell transplantation (HCT) will be presented. EBV-LPD is a serious malignancy with an unmet medical need that occurs after HCT and in other patients with immune deficiencies. The U.S. Food and Drug Administration (FDA) recently granted breakthrough therapy designation for EBV-CTL based on the data from the two studies. The AACR annual meeting is being held in Philadelphia, Pennsylvania from April 18th to April 22nd, 2015.

Under Atara's exclusive option agreement with MSK, Atara has the right to license the exclusive, worldwide rights to three clinical stage T-cell programs, including EBV-CTL.

**About EBV-CTL**

T-cells are a critical component of the body's immune system and can be harnessed to counteract viral infections and some cancers. By focusing the T-cells on specific proteins involved in cancers and infections, the power of the immune system can be employed to combat these diseases. EBV-CTL utilize a technology in which T-cells are collected from the blood of third-party donors and then exposed to EBV antigens. The resulting activated T-cells are then expanded, characterized, and stored for future therapeutic use in an appropriate partially human leukocyte antigen, or HLA, matched patient, providing an "off-the-shelf", allogeneic, cellular therapeutic option for patients. In the context of EBV-LPD, the EBV-CTL find the cancer cells expressing EBV and kill them. EBV-CTL are currently being studied in two ongoing Phase 2 clinical trials (NCT00002663 and NCT01498484).
