# **Astronics Awarded Development and Production Contract for Anti-Collision Light Kits**

## **-- Designed for the T-45 Goshawk Naval Training Aircraft**

Boeing has delivered more than 200 T-45 Goshawk's.

Designed using light emitting diode (LED) technology as its illumination source, the cutting-edge anti-collision light will replace rotating beacon lights currently mounted on the fuselage and provide a significant improvement in performance and reliability. Astronics' aircraft navigational lighting products are designed to withstand the extreme shock and vibration common to the rugged environment of military aircraft.

Development of the product is scheduled to be completed in January 2009 with product shipments to span a one-year period beginning in June 2009.
