## Ur-Energy Announces Start of 2011 Drilling Program

LITTLETON, COLORADO -- (MARKET WIRE) -- 07/19/11 -- Ur-Energy Inc. (TSX: URE) (NYSE AMEX: URG)("Ur-Energy" or the "Company") is pleased to announce the start of the 2011 drilling program at the Lost Creek Project (the "Project") as well as the continuation of its exploration efforts at its Lost Creek North property. The Company returned to the field with four drill rigs on July 18, 2011 to install wells and perform exploration drilling.

With Project permitting nearly complete, the Company is installing several wells which will be utilized to conduct hydrology testing on the KM horizon. This is in preparation of a future license/permit amendment to include the KM horizon as an approved mining formation. The remainder of the 2011 drilling program will be focused on exploring for uranium within a previously undrilled area of the Project and in the adjacent Lost Creek North property.

John Cash, Vice President of Regulatory Affairs, Exploration & Geology stated "The continued drilling at the Lost Creek Project and its adjacent properties reaffirms the Company's continued commitment to further develop its resources. Ur-Energy's position in the Great Divide Basin continues to be enhanced through our ongoing drilling and exploration programs."

### About Ur-Energy

Ur-Energy is a junior uranium company currently completing mine planning and permitting activities to bring its Lost Creek Wyoming uranium deposit into production. Permitting also will allow the construction of a two-million-pounds-per-year in situ uranium processing facility. Engineering for the process facility is complete and mine planning is at an advanced stage for the first two mine units. Ur-Energy engages in the identification, acquisition and exploration of uranium properties in both Canada and the United States. Shares of Ur-Energy trade on the Toronto Stock Exchange under the symbol "URE" and on the NYSE Amex under the symbol "URG".
