

## New Casino Table Games to be Introduced in Louisiana

LAS VEGAS, March 5, 2013 (GLOBE NEWSWIRE) -- Galaxy Gaming, Inc. (GLXZ), announced today it has received approval from the Louisiana Gaming Control Board to provide its products to casinos in the state.
