## Peruvian Pension Regulator Approves Sale of 12 ETFs in Peru

NEW YORK, Feb. 26, 2014 (GLOBE NEWSWIRE) -- WisdomTree Investments, Inc. (Nasdaq:WETF), an exchange-traded fund ("ETF") sponsor and asset manager, today announced the Superintendencia de Banca, Seguros y AFP (SBS), the Peruvian pension funds investment regulator, has approved 12 WisdomTree ETFs for sale to Peruvian pension funds. This is a necessary condition before they can be purchased in accordance with pension plan investment guidelines. There are currently approximately \$40 billion (USD) in assets invested in Peruvian pension funds. <sup>1</sup>

"ETF adoption continues to increase throughout Latin America. We are pleased that 12 of our ETFs are approved for sale to Peruvian pension funds, further expanding our global footprint," said Luciano Siracusano, WisdomTree Chief Investment Strategist.
