

## MAXIMUS Awarded Renewal on Medicare Appeals Contract

RESTON, Va.--(BUSINESS WIRE)--

The Centers for Medicare & Medicaid Services (CMS) has renewed its contract with MAXIMUS Federal Services, a subsidiary of MAXIMUS (NYSE:MMS), for 2008 under a three-year contract under which MAXIMUS processes appeals related to the Medicare Part D prescription drug program. The contract renewal is valued at approximately \$14 million.

Under this contract, MAXIMUS Federal Services receives and impartially adjudicates appeals from Medicare beneficiaries, resulting from a denial made by a Medicare Advantage-Prescription Drug plan or a stand-alone Prescription Drug Plan. MAXIMUS Federal Services provides Part D appeals services as a Qualified Independent Contractor (QIC) to CMS.

In addition to its role as a Part D QIC, the Company also provides appeals nationwide for Medicare Part C (Medicare Advantage) and for traditional Medicare Part A for the eastern half of the United States.

"MAXIMUS has successfully provided CMS, and its predecessor agency, with Medicare appeals services since I989, and we are delighted to build on this track record with this project renewal," said MAXIMUS CEO Richard Montoni." As a QIC, we have demonstrated our ability to make decisions, including those related to medical necessity, that afford thousands of beneficiaries the highest level of independence and objectivity."
