## **GSRX Industries to Present at CannaStocks 2019 Q1 Investor Conference on May 15 in New York**

DORADO, Puerto Rico, May 14, 2019 (GLOBE NEWSWIRE) -- GSRX Industries Inc. (OTCQB: GSRX) ("GSRX" or the "Company") Executive Chairman Christian Briggs will present to an investor audience at the cannabis industry's highly anticipated CannaStocks 2019 Q1 Investor Conference on Wednesday, May 15 in New York. GSRX is one of the largest medicinal cannabis dispensary operators in the U.S. Commonwealth of Puerto Rico, and also operates adult use and medical dispensaries in California. In addition, the Company's majority-owned subsidiary Spirulinex has approximately 40 patents pending for water soluble cannabis formulizations.

The conference will take place at the OTC Markets Group offices in New York and will feature company presentations and discussions regarding current market trends from OTC Markets QX and QB tier Issuers. Mr. Briggs is scheduled to present at 4:45 pm, followed by a Q & A with conference attendees. Importantly, the presentation and Q & A will be live-streamed worldwide in partnership with Midtown Partners & Co, LLC. At tomorrow's conference, GSRX's Briggs and other participants will provide insight on important themes of particular interest to investors, including: innovation, consolidation, international expansion and specialization.

GSRX recently announced financial results for the 4th quarter of 2018 and its full year 2018 results, reporting record revenues of \$1.66 million for the quarter – an increase of 135% over the prior quarter. Additionally, the Company recently announced record 1st quarter revenues of \$2.9 million (unaudited), with a rise in gross profit to 51.76%.

GSRX Industries Inc. (OTCQB: GSRX), through its subsidiaries, is in the business of acquiring, developing, and operating retail cannabis dispensaries and non-THC CBD retail stores. GSRX also is in the process of expanding its business to include distribution, extraction and light manufacturing, and delivery of cannabis and cannabinoid products. Currently, GSRX operates five cannabis dispensaries in Puerto Rico under the name Green Spirit RX, one dispensary in California under the name The Green Room, and has five additional pre-qualified locations in Puerto Rico, all of which are in various phases of development and construction. GSRX also owns and operates the e-commerce site GetPureAndNatural.com, which offers a broad range of premium hemp extract products.
