# MaxLinear Names Tom Pardun to Board of Directors

## Industry Veteran Brings Consumer Technology and Telecommunications Experience to Fast Growing RF & Mixed Signal IC Company

Before joining U.S. West, Mr. Pardun was president of the Central Group for Sprint, as well as president of Sprint's West Division and senior vice president of business development for United Telecom, a predecessor company to Sprint. Mr. Pardun also held a variety of management positions during a 19-year tenure with IBM, concluding as Director of product-line evaluation. He is also a director of CalAmp Corporation and Occam Networks, Inc.
