# Miami Freedom Park Selects Evolv Technology for All Guest Ingress Screening at New World-Class Stadium

*Inter Miami CF's state-of-the-art stadium to utilize Evolv Express® and Evolv eXpedite™*

(NASDAQ: EVLV), a leading security technology company pioneering AI-based solutions designed to create safer experiences, today announced that [Evolv Express®](#) has been selected for use stadium-wide at [Inter Miami CF's](#) new home located at Miami Freedom Park.

Evolv Express Gen2 systems will be installed at the new 25,000-seat Florida stadium, which is slated to open on April 4, 2026. Evolv Express was designed to allow people to move through screening at their natural walking pace, aiming to provide a welcoming security screening experience for fans.

The stadium will also utilize the [Evolv eXpedite™](#) autonomous x-ray bag scanner for additional screenings.

Concurrent with the deployment, Evolv has been designated as the “Official Fan Screening Provider of Miami Freedom Park.” The company will have a brand presence inside the new stadium on match days and year-round on the venue’s digital media.

“It’s especially gratifying to add Miami Freedom Park to our professional sports customer roster, which now stands at over 60 teams and venues in the U.S. and Canada,” said John Baier, Evolv’s Vice President of Sports & Entertainment. “Just as the Stadium is cutting edge in design, Express and eXpedite are cutting edge in security screening technology. It’s an ideal combination, and we’re excited to help deliver on the team’s vision to build a first-class destination for Miami and the world.”

Evolv Express has been used at all match venues and select training sites during prominent global soccer competitions. Worldwide, Evolv counts nearly 100 customers on its sports and entertainment roster, and more than 1,100 across all verticals. The deployment also expands Evolv’s substantial existing footprint in the Sunshine State, joining [Benchmark International Arena \(formally Amalie Arena\)](#) in Tampa, among others.

Spanning 131 acres, Miami Freedom Park is the largest active real estate development in Miami and one of the most significant sports-anchored mixed-use projects underway in the United States. Developed by the ownership group of Inter Miami CF, the district is anchored by a new 25,000-seat, world-class stadium and is being delivered as a phased, year-round destination designed to serve Miami residents, the region, and visitors alike—on matchdays and far beyond. The multi-phase development program includes more than 1 million square feet of retail, dining, entertainment, and office space, alongside multiple hotels totaling 750 hotel rooms and a robust network of civic spaces, plazas, and recreational amenities designed for daily and seasonal activations. At its core, Miami Freedom Park integrates professional sports, live entertainment, hospitality, commerce, and public life into a single, highly connected campus that supports daily activity as well as large-scale international events. Miami Freedom Park also incorporates the 58-acre Jorge Mas Canosa Park—the largest new public park planned in the City of Miami in generations—along with community athletic fields and expansive outdoor gathering areas. Construction on the project began in 2023 and will commence opening in phases beginning in 2026, starting with the stadium and select district components, including youth athletic fields, programmed civic and plaza spaces for fan zones and seasonal activations, and an inaugural collection of restaurants, attractions, and retailers.
