# **Amtech Announces \$32 Million in New Solar Orders in January 2011**

Fiscal 2011 Year-to-Date Solar Orders Total \$159 Million

TEMPE, Ariz.--(BUSINESS WIRE)-- Amtech Systems, Inc. (NASDAQ: ASYS), a global supplier of production and automation systems and related supplies for the manufacture of solar cells, semiconductors, and silicon wafers, today announced that its solar subsidiary, Tempress Systems, Inc., has received approximately \$32 million in new solar orders in January for its diffusion processing systems from new and existing customers in Asia. Amtech's fiscal 2011 began October 1, 2010.

We believe the intense effort by our customers and the solar industry to increase cell efficiency will continue to drive demand for our superior diffusion technology. The Company's wafer handling, thermal processing and consumable products currently address the diffusion, oxidation, deposition, PECVD, and PSG removal steps used in the fabrication of solar cells, semiconductors, MEMS and the polishing of newly sliced silicon wafers.
