

## Red Robin Appoints Tacoma, Wash.-area's Michael Morrison as its First-Ever Chief Burger Officer

Morrison chosen from more than 7,200 burger-loving contenders to be appointed to this honorary role for the gourmet burger chain

GREENWOOD VILLAGE, Colo.--(BUSINESS WIRE)-- The search has ended! Red Robin Gourmet Burgers, Inc. In his role as CBO, Morrison will fly to Denver to visit Red Robin's headquarters and enjoy the executive perks that come with his new title, including a business lunch with Red Robin CEO Steve Carley and time in the Red Robin kitchen learning the art of the Smiling Burger with Red Robin's executive chef, Dave Woolley.

"Michael went above and beyond to prove he has what it takes to deserve the title of Red Robin Chief Burger Officer," said Carley. The extensive lobbying paid off, and while the CBO appointment was ultimately made by a team of Red Robin executives, Morrison received 6,899 votes, making him a standout candidate with the selection committee.
