The C-Bond technology chemically bonds to the defects randomly distributed on the glass surface to increase impact resistance and prevent breakage. C-Bond BRS is validated by an independent third-party laboratory to provide National Institute of Justice (NIJ) Level I, Level IIA, Level II, and Underwriters Laboratories (UL) 752 ballistic-resistant protection.

A1 Glass is an expert installer of C-Bond BRS and C-Bond Secure, which is a window film application to deter forced entry, in multiple schools and other facilities throughout Texas. C-Bond BRS and C-Bond Secure can be installed on existing glass surfaces or can be retrofitted into the existing framing system without the additional cost for structural changes to business design.
