

## CLS Holdings USA, Inc. Acquisition Target Oasis Cannabis Records Highest Wholesale Sales Month in March

City Trees Wholesale Sales Will Exceed \$370,000 in March 2018 with 68% Growth Over February 2018

LAS VEGAS, NV -- (Marketwired) -- 04/03/18 -- CLS Holdings USA, Inc. (OTCQB: CLSH) "CLS," a development stage diversified cannabis company operating as Cannabis Life Sciences, today announced that City Trees, the wholesale division of its acquisition target Oasis Cannabis, recorded its largest sales month on record since wholesale sales operations began in August 2017.

March sales will exceed the previous record set by City Trees in February by more than \$150,000. Strong new customer growth and consistent reordering from existing dispensary customers are the main drivers behind the spike in sales. City Trees added 6 new dispensary customers in the last 60 days and it will likely set another sales record in April, according to Don Decatur, Director of Operations for City Trees. Decatur said the great results are attributed to quality products. "Customers really appreciate the quality of the products we're making," explained Decatur. "We are proud of our ability to reach this level of sales with our existing use of only 1,150 square feet within our 22,000 square foot facility. I'm excited about what we may be able to accomplish when we're finished expanding our facilities in a few months."

Oasis Cannabis is a fully integrated cannabis operation in Nevada. Las Vegas-based Oasis Cannabis' (<a href="http://oasiscannabis.com">http://oasiscannabis.com</a>) operations include a grow, extraction and conversion processing and a retail dispensary. CLS has executed a definitive agreement to acquire Oasis. The closing of the transaction, which is subject to the satisfaction of a number of conditions, is expected to occur in the second quarter of 2018.

Oasis Cannabis has operated a cannabis dispensary in the Las Vegas market since dispensaries first opened in Nevada in 2015 and has been recognized as one of the top marijuana retailers in the state. An expansion of its cultivation and production facility is currently underway and is expected to be completed during the second half of 2018.
