Going Up: CLS Holdings USA, Inc. Announces November Results With Record Breaking Gross Profit Margin

LAS VEGAS, NV / ACCESSWIRE / December 14, 2021 /CLS Holdings USA, Inc. (OTCQB:CLSH)(CSE:CLSH), the "Company" or "CLS", a diversified cannabis company operating as Cannabis Life Sciences, today announced the financial and operational results for its Nevada wholly owned subsidiaries for the month of November 2021 with net revenues of \$1.8M and a gross margin of 56%. This represented a significant monthly increase in gross margin of 20% year over year and 66% over 2019 as well as the largest gross margin the Company has ever achieved. The wholesale branded division at City Trees remained hot with monthly net revenue growth of 91% year over year and 132% over 2019.

CLS Nevada November 2021 Financial and Operational Highlights

- The Company's retail division, Oasis Cannabis continued to exceed its goal of a greater than \$50 average order size with orders averaging \$54 in November
- The Company's branded division, City Trees, continued to outperform the market and achieved a 91% increase in year-over-year revenue and a 132% increase from 2019
- City Trees continued to maintain its position as the number one selling tincture brand in the state of Nevada
- The Company achieved its greatest monthly gross profit margin to date
- BDS Analytics numbers reflected that City Trees was the number one brand for the entire concentrate category in units sold in the state of Nevada during October, selling over 46,000 units.

"It's been an exciting 2021," noted Company President & COO Andrew Glashow. "We are all systems go at this point. With our innovation lab pumping out what we believe to be the best quality product in the state of Nevada, a growing number of consumers continuing to purchase City Trees and show up at our OASIS dispensary we are poised for continued growth in '22. The future looks bright at CLS!"

Please note that effective as of January 2022, the Company will transition from monthly to quarterly reporting and will hold investor quarterly calls.
