Main Street Issues Reminder Regarding Upcoming Dividend Activity

HOUSTON, Dec. 10, 2015 /PRNewswire/ -- As previously announced on October 21, 2015, Main Street Capital Corporation (NYSE: MAIN) ("Main Street") will pay a semi-annual supplemental cash dividend of \$0.275 per share in December 2015, which is in addition to Main Street's previously announced regular monthly cash dividends of \$0.18 per share to be paid in each of December 2015 and January, February and March 2016. Consistent with prior periods with several dividends in close proximity, Main Street is issuing this reminder with respect to its upcoming dividend activity since there are multiple ex-dividend and payment dates in December 2015.

Each of Main Street's December 2015 and January 2016 regular monthly dividends and December 2015 semi-annual supplemental dividends will be payable as set forth below to stockholders who hold shares through the trading day immediately preceding the ex-dividend date for such dividend.

- (1) Additionally, Main Street has previously declared regular monthly dividends of \$0.18 per share payable on February 17, 2016 and March 15, 2016 to stockholders of record on January 22, 2016 and February 22, 2016, respectively.

Including all dividends declared to date, Main Street will have paid \$16.42 per share in cumulative dividends since its October 2007 initial public offering at \$15.00 per share. The combination of the current regular monthly dividend rate of \$0.18 per share and the current semi-annual supplemental dividend rate of \$0.275 per share equates to annualized cash dividends of \$2.71 per share.
