## Blüm RULES AND REGULATIONS

**MEDICAL MARIJUANA ESTABLISHMENT** I understand that Blüm was established to provide a professionally administered and legally structured collective for the benefit of all its members.

**PHYSICIAN RECOMMENDATIONS AND REGISTRY CARDS** Patients at Blüm must have a recommendation for medical cannabis by a licensed doctor of medicine or doctor of osteopathy as required by California law. Patients must provide Blüm with a current valid government-issued photo identification card, along with their current valid California Medical Marijuana Registry Card or a current valid nonresident medical marijuana card issued by state or jurisdiction other than California, upon each visit to Blüm to enter the sales area and/or to make a purchase. Blüm will keep those documents on file.

**CONFIDENTIALITY** All personal information collected by Blüm is confidential and private. Such information will not be released to any third party without your written consent. However, Blüm may be required by court order or by the California Division of Public and Behavioral Health to release certain information and Blüm must comply.

### NOTICE TO PATRONS

- A. Use of medical marijuana shall be limited to the patient identified on the doctor's recommendation. Secondary sale, barter, or distribution of medical marijuana is a crime and can lead to arrest.
- B. Forgery of medical documents is a felony crime.
- C. A warning that patrons may be subject to prosecution under federal marijuana laws.
- D. That the use of medical marijuana may impair a person's ability to drive a motor vehicle or operate machinery.
- E. All prices include applicable sales tax.
- F. I understand that Blüm operates within full compliance of all applicable California Laws relating to the cultivation, possession, transportation and use of medical marijuana.
- G. I understand that all donations made to Blüm are to be used to reimburse for actual expenses and reasonable costs for the administration of the collective. Furthermore, all donations are for the continued operation of the collective and that any said donation in no way constitutes a commercial promotion or sale of any item.
- H. The loitering on and around the collective site is prohibited by California Penal Code 647(e) and that patrons must immediately leave the site and not consume medical marijuana in the vicinity of the collective or on the property or in the parking lot.

**USE OF CELL PHONES, CAMERAS, RECORDING DEVICES, OR ELECTRONIC COMMUNICATION DEVICES, OR RECORDING DEVICES IS PROHIBITED BEYOND THE WAITING ROOM. WEAPONS OF ANY KIND ARE NOT ALLOWED ON THE PREMISES.**

**NO PUBLIC USE OR ONSITE CONSUMPTION** The use of medical cannabis in public view is illegal in the state of California. Consumption of medical cannabis, illegal drugs, tobacco or alcohol on the entire premises of Blüm is strictly prohibited.

**PRE-ORDERS** After pre-orders services become available, patients and caregivers who call ahead or use the online pre-order system to reserve products are given priority and skip ahead in line.

**PAYMENT FOR SERVICES** Payment is expected at time of transaction/service. Patients are not allowed to touch any of the items containing medical cannabis until their transaction is complete. To comply with state medical marijuana laws, refrain from opening your purchases until after you leave the premises. Credit card use will be permitted for patients only.

Blüm reserves the right to refuse service to any person at any time, for any reason.
