

Microchip Technology Declares Quarterly Cash Dividend Of 36.0 Cents Per Share

CHANDLER, Ariz., Aug. 8, 2016 /PRNewswire/ -- (NASDAQ: MCHP) – Microchip Technology Incorporated, a leading provider of microcontroller, mixed-signal, analog and Flash-IP solutions, today announced that its Board of Directors has declared a quarterly cash dividend on its common stock of 36.0 cents per share. The dividend is payable on September 6, 2016 to stockholders of record on August 22, 2016. Microchip initiated quarterly cash dividend payments in the third quarter of fiscal year 2003 and has increased its dividend 49 times since its inception.



"Microchip achieved very strong results in the June 2016 quarter and the operating cash flow from the business was very strong," said Steve Sanghi, Chief Executive Officer and Chairman of the Board. "Our Board of Directors is pleased to declare an increase in our quarterly dividend to a record 36.0 cents per share, which continues to reflect our ongoing commitment to returning value to our stockholders."
