We will never knowingly collect any personal information about children under the age of 13. If we obtain actual knowledge that we have collected personal information about a child under the age of 13, that information will be immediately deleted from our database. #### 1. How we collect information.

#### 1.1 Information you provide

We collect information from you by various methods, such as when you complete a product survey, order form, or a registration page either online or offline (such as in person, by mail, by phone, and similar means), or when you complete online or offline surveys, order forms, or registration pages operated by third parties who sell that information to us (collectively, a "Survey"). ### 1.2 Information from third parties

## 2.1 Our discretion to use information
