Eric Church Live Concerts To Broadcast Exclusively On SiriusXM's The Highway Channel

Friday night concert series brings SiriusXM listeners on the Double Down Tour

Additionally, SiriusXM The Highway host Buzz Brainard will take his weekly *Music Row Happy Hour* show on the road, joining Eric Church fans at Cowboy Jack's in Minneapolis on February 8 and at Tin Roof in Cincinnati on February 22 before each night's concert broadcast.

SiriusXM's live broadcasts from Eric Church's concerts will air every Friday in February at 8:00 pm local via satellite on channel 56 and through the SiriusXM app on smartphones and other connected devices, as well as online at siriusxm.com.

Eric Church is the latest megastar whose concerts will air live exclusively on SiriusXM, joining other artists such as Dave Matthews Band, Zac Brown Band, Jimmy Buffett and more.
