The nation is facing a severe blood shortage due to a large number of blood drive cancellations during the COVID-19 pandemic, according to the American Red Cross. To address the need, mobile blood donation buses will be located on-site at Lakewood Church and the Gulf Coast Regional Blood Center is following all heightened CDC recommendations regarding sanitization and safety to provide a clean, safe environment for donations.
