

# National Storage Affiliates Trust Announces Pricing of Upsized Public Offering of Common Shares

GREENWOOD VILLAGE, Colo.-- National Storage Affiliates Trust ("NSA" or the "Company") (NYSE:NSA) today announced the pricing of its underwritten public offering of 10,475,000 common shares of beneficial interest of the Company at a public offering price of \$20.75 per share for gross proceeds of \$217.4 million. The offering was upsized from 8,750,000 common shares to 10,475,000 common shares. The Company has also granted the underwriters a 30-day option to purchase up to an additional 1,571,250 common shares at the public offering price, less underwriting discounts.

The Company expects to close the offering on or about July 6, 2016, subject to the satisfaction of customary closing conditions. The Company intends to use the net proceeds from the offering to repay amounts outstanding under its revolving line of credit and to redraw on its revolving line of credit from time to time to invest in future acquisitions of self storage properties and for general corporate and working capital purposes.

Jefferies, Morgan Stanley, Wells Fargo Securities, KeyBanc Capital Markets, RBC Capital Markets and BMO Capital Markets are acting as joint book-running managers for the offering. Baird and SunTrust Robinson Humphrey are acting as joint lead managers and BTIG and Capital One Securities are acting as co-managers for the offering.

A registration statement relating to these common shares has been declared effective by the Securities and Exchange Commission ("SEC"). The offering is being made only by means of a prospectus supplement and accompanying prospectus.
