Michel Landel was appointed CEO of Sodexo Group in 2005. Since then, he has led Sodexo’s transformation to become the global leader in Quality of Life services. Landel’s commitment to diversity and inclusion has resulted in the organization being considered a recognized leader in the area. Under Landel’s leadership, Sodexo was honored with the prestigious 2012 Catalyst Award for its diversity and inclusion strategy that resulted in systemic cultural change for the organization. Sodexo was also ranked #1 in 2010 and #2 in 2011. Sodexo was ranked #1 on the DiversityInc business index of Top Companies for Diversity & Inclusion in 2013 and #2 in 2012.

Landel has received many distinguished honors including the CEO Leadership Award from Diversity Best Practices and the CEO Advocate of the Year award from Asian Enterprise magazine. In 2016, at the United Nations Women’s Empowerment Principles awards, Michel Landel was awarded the CEO Leadership Award. He is a Chevalier of the French Legion of Honor, sits on the Catalyst Board of Directors, and plays a leadership role in the Women’s Forum CEO Champions

PDN’s participation at the Women’s Forum Global Meeting is another example of PDN’s place in the global conversation on women’s issues and commitment to its members. The Company previously disclosed its long-term plan to enhance the lifetime value of its networking memberships, including those now beginning to be sold through its IAW segment

in China.

The Company continues to focus on bringing global attention to women's issues, which grows awareness of networking, while specifically spotlighting its brand within that broader conversation.

The Company previously announced that on December 2, 2017, it will hold its First Nasdaq Global Capital Summit Forum, an exclusive forum focused on entrepreneurialism in Beijing, China at the Qihua Resort.

The event will be headlined by Bruce Aust, Vice Chairman of Nasdaq and hosted by PDN President Star Jones. The event is expected to be the Company's highest attended event, potentially drawing as many as 5,000 paid participants, setting the stage for the Company's 2018 growth plans.
