Erich Mauff Acquires Super Voting Shares of Jushi Holdings Inc.

BOCA RATON, FL, June 10, 2019 /CNW/ - On June 6, 2019, Jushi Holdings Inc. (formerly, Tanzania Minerals Corp., the "**Issuer**"), located at 1800 NW Corporate Blvd., Suite 200, Boca Raton, FL 33431, and Jushi Inc ("**Jushi**") completed its previously announced business combination (the "**Business Combination**"), to create a vertically integrated multi-state cannabis and hemp operator.

Erich Mauff (the **"Acquiror**"), President and director of the Issuer, located at 413 W. 14th St., Suite 237, New York, NY 10014, announced today that in connection with the Business Combination, the Acquiror, together with his joint actors, acquired beneficial ownership or control or direction over 20,000 Super Voting Shares (the **"Acquired Securities"**), which represents 13.4% of the class of Super Voting Shares.

Each Super Voting Share is entitled to 100 votes per share and is convertible into 100 Subordinate Voting Shares. The Super Voting Shares were issued in exchange for the Acquiror's Class A Shares of Jushi. Immediately prior to the Business Combination, the Acquiror and his joint actors owned or controlled no securities of Tanzania Minerals Corp.

In connection with the acquisition, the Acquiror entered into a lock-up agreement with the agents pursuant to which such parties have agreed, subject to customary carve-outs and exceptions, that their Subordinate Voting Shares and Super Voting Shares, as applicable, and the securities convertible thereinto, or any securities issuable in exchange therefor, will be released in tranches over a period of sixteen (16) months from the date the Subordinate Voting Shares are listed on the NEO Exchange Inc.
