During the month of May, 5% of Alaska Brand Fertilizer purchases at Lowe's stores nationwide will be donated to the Cornell Lab of Ornithology to fund the grant program, providing ongoing opportunities for future student science, technology, engineering and math (STEM) learning that positively affects children and their communities.

The garden grant program was started in 2015 to provide deserving school districts, most in underserved urban markets, opportunities to engage in science-based, hands-on, outdoor learning experiences. Research shows that students who participate in a garden-based science curriculum, in addition to traditional classroom learning, score significantly higher on science achievement tests than students in a traditional classroom-based control group. This garden-enhanced achievement benefits both boys and girls equally.
