Wilson previously served as General Manager of Accelera’s Electrified Components business and helped initiate the recently announced [battery cell manufacturing joint venture](#) with Daimler Truck and PACCAR.

Wilson joined Cummins in 2008, taking on a variety of roles throughout his tenure, including in corporate strategy, the growth office, and as General Manager of the global bus business. He also held previous roles at Interbrand and ATA Airlines. Wilson earned a bachelor’s degree in acoustical engineering from Purdue University and an MBA from Indiana

Lippert most recently served as Vice President of Accelerator Engineering and was instrumental in developing technology infrastructure and optimizing technical collaboration.
