

## Ayr Strategies Announces Pricing of Offering of Equity Shares

TORONTO, Jan. 12, 2021 /CNW/ - Ayr Strategies Inc. (CSE: AYR.A) (OTCQX: AYRWF) ("Ayr" or the "Company"), a leading vertically integrated cannabis multi-state operator, announced today the pricing of its previously announced overnight marketed offering (the "Offering") of an aggregate of 4,000,000 subordinate voting shares, restricted voting shares or limited voting shares (the "Offered Securities") at a price of C\$34.25 per share for total gross proceeds of approximately C\$137,000,000.

The Offered Securities will be offered in each of the Provinces of Canada, other than Québec, pursuant to a prospectus supplement to the Company's base shelf prospectus dated December 17, 2020 (the "**Prospectus**") and in the United States on a private placement basis to "qualified institutional buyers" pursuant to an exemption from the registration requirements of the United States Securities Act of 1933, as amended (the "**U.S. Securities Act**").

The Offering is expected to close on or about January 14, 2021 and will be subject to customary conditions, including requirements of the Canadian Securities Exchange.

In addition, the Company has granted the underwriters a 30-day option to purchase up to an additional 15% of the Offered Securities pursuant to the proposed Offering on the same terms and conditions.

The Company intends to use the net proceeds of the Offering for working capital and general corporate purposes.

Canaccord Genuity Corp. is acting as the lead underwriter for the Offering.
