Wheeler Real Estate Investment Trust, Inc. Announces Launch of Series D Preferred Stock Follow-On Offering

VIRGINIA BEACH, Va., Nov. 28, 2016 (GLOBE NEWSWIRE) -- **Wheeler Real Estate Investment Trust, Inc.** (NASDAQ:WHLR) (“Wheeler” or the “Company”), a company specializing in owning, acquiring, financing, developing, renovating, leasing and managing income-producing assets, such as community centers, neighborhood centers, strip centers and freestanding retail properties, announced today that it has commenced a follow-on public offering of Series D Cumulative Convertible Preferred Stock (“Series D Preferred Stock”), subject to market and other conditions. The Company expects to grant the underwriters a 30-day option to purchase additional shares to cover overallocments, if any. The Series D Preferred Stock trades on the Nasdaq Capital Market under the symbol “WHLRD.”

The Company intends to use the net proceeds from this offering to repay its loan with Revere High Yield Fund, LP, for future mainly grocery-anchored acquisitions and investments and additional working capital.

Compass Point Research & Trading, LLC, Ladenburg Thalmann & Co. Inc. and Wunderlich Securities, Inc. are serving as book-running managers for the offering.

The offering is being made pursuant to the Company’s shelf registration statement, which was declared effective by the U.S. Securities and Exchange Commission (“SEC”) on September 6, 2016.
