Galaxy Gaming Acquires T & P Gaming's Table Game Business

Acquisition Includes Popular "Deuces Wild" Game

LAS VEGAS, April 19, 2010 (GLOBE NEWSWIRE) -- Galaxy Gaming, Inc. (OTCBB:GLXZ), announced today it acquired the table game business of T & P Gaming, Inc., a Nevada company which previously specialized in distributing table games in Nevada, Mississippi and Indiana. T & P Gaming's primary product was the "Deuces Wild Hold'em Fold'em" game, a house-banked game which is played on a casino's table gaming floor. The acquisition, accomplished through an asset purchase agreement, also included rights to a game called "Random Wild" and the associated intellectual property, hardware and marketing collateral for both games. Deuces Wild is currently played in casinos in Nevada and Mississippi. The licensing agreements between those casinos and T & P Gaming have been assigned to Galaxy Gaming.

Tom Gaytan, President of T & P Gaming, commenting on the sale, stated, "Our company prospered early with the success of Deuces Wild, however we lacked a sufficient distribution network to make the game one of the casino table game industry's top producers. Galaxy Gaming has an excellent distribution network and I am confident they will do extremely well with our products going forward. T & P Gaming will continue to develop games for the slot industry," added Mr. Gaytan.

"We are delighted to add these two games to our existing portfolio of table game products and welcome T & P's customers to Galaxy Gaming," commented Robert Saucier, Galaxy Gaming's Chief Executive Officer. "Our research showed Deuces Wild to be a very popular game among players and is in fact, the only successful casino poker table game which incorporates wild cards. Until now, it was offered only on a limited scale to casinos. We intend to broaden its availability significantly."

Galaxy Gaming previously announced a scheduled conference call to be held on Wednesday, April 28th at 5:00pm EDT to discuss its recently filed 2009 results.
