("Cheniere") (NYSE Amex: LNG) announced today the closing of the sale of its 30 percent limited partner interest in Freeport LNG Development L.P. for net proceeds of approximately \$104 million to ZHA FLNG Purchaser, LLC, an entity formed by Zachry American Infrastructure, LLC and Hastings Funds Management (USA), Inc. on behalf of institutional investors.
