Car Charging Group plans to install EV charging stations at sites owned by the two parking garage operators. The operators have 2,200 locations nationwide with 1.1 million parking spaces.

As part of the agreement, Central Parking has the right to purchase five percent of the Common Stock of Car Charging Group. "We are very excited about this partnership, because it will greatly expand the reach of our nationwide EV charging network," said Michael Farkas, CEO of the Miami Beach, Fla.-based Car Charging Group. "Furthermore, we hope to further enhance our already strong relationship with these companies by giving Central Parking the opportunity to be a shareholder in our company and to take part with us in electrifying the U.S. transportation system."

Central Parking believes that electric vehicles can make a difference in the transportation sector, and they look forward to being a partner in building a nationwide network of EV charging stations.
