Ownership of the EV charging stations remains with Car Charging Group. Ace Parking will share in the proceeds generated by the charging services provided at their facilities.

"Forward-thinking parking garage owners and managers such as Ace Parking understand the economic and environmental benefits of installing EV charging stations, as well as their importance to the developing EV industry and their role in attracting environmentally conscious customers."
