## **PNC Declares Dividend of 63 Cents on Common Stock**

PITTSBURGH, Jan. 3 /PRNewswire-FirstCall/ -- The PNC Financial Services Group, Inc. (NYSE: PNC) today announced that the board of directors declared a quarterly cash dividend of 63 cents per share on the common stock. The dividend is payable Jan. 24, 2008 to shareholders of record at the close of business Jan. 11, 2008.

The board also declared a quarterly cash dividend on the following preferred stocks:

- Series A and B: a dividend of 45 cents per share will be payable March 10, 2008 to shareholders of record at the close of business Feb. 15, 2008.
- Series C: a dividend of 40 cents per share will be payable April 1, 2008 to shareholders of record at the close of business Feb. 29, 2008.
- Series D: a dividend of 45 cents per share will be payable April 1, 2008 to shareholders of record at the close of business Feb. 29, 2008.
