

# Security Devices International Receives 3,000 Unit Purchase Order for its 'Byrna™ HD' Non-Lethal Personal Security Device from Leading Firearms Distributor in Africa

Initial \$600,000 PO to be Delivered in December 2018 for Law Enforcement, Private Security and Consumer Markets in South Africa

("SDI" or the "Company") (CSE: SDZ) (OTCQB: SDEV), an emerging non-lethal technology company, has received a 3,000 unit purchase order for its Byrna™ HD non-lethal personal security device from Dave Sheer Guns, a leading distributor of firearms and accessories in Africa.

The initial purchase order includes 1,500 units in all black for the law enforcement and private security markets and 1,500 units in desert tan for the consumer market in South Africa. Dave Sheer Guns commenced operations in 1974 and is now one of the leading distributors of firearms and accessories on the African continent.

The Byrna™ HD (Home Defense) is a disruptive new non-lethal device aimed at the home defense and personal security markets. Its patented design, compact size, five-round magazine, laser sight adaptability and point and shoot capabilities will make the Byrna™ a truly effective personal security device offering many of the same features as today's popular handguns, but with one critical difference — it fires non-lethal rounds which do not result in the loss of human life. Instead, the Byrna™ delivers a chemical payload that causes an immediate burning sensation in the attacker's eyes and respiratory system (hence the name "bur-nah") thereby **D**eterring, **D**isorienting, **D**isrupting and **D**elaying an attacker, providing time to escape or call for assistance.

"The South African market is ideal for Byrna™ sales as it is a microcosm of the much broader clash of societal forces clamoring for better security but at the same time, limiting handgun ownership," said Paul Jensen, CEO of SDI. "The team at Dave Sheer Guns saw a natural void in their product offering that Byrna™ could fill based on increased interest from customers looking for an economical and concealable non-lethal alternative."

"We believe South Africa represents a greenfield opportunity for Byrna™ adoption as only 6% of the South African population own a firearm due to strict gun control laws," added Bryan Ganz, President of SDI. "Providing a safe, non-lethal alternative for personal security will not only keep that statistic low, but also ensure much needed protection for today's consumer and law enforcement personnel," concluded Ganz.

The Byrna™ HD will not require a gun license and has a starting price of \$299. It will be able to be fitted with laser sights or flashlights and fit easily in either an inside the waistband or tactical holster. The Byrna™ HD was designed for those wanting a way to stop an attacker at standoff distances far beyond what is generally available on the market today (except with a lethal device), in order to disarm a threat before it escalates out of control and without the need to use deadly force. It's ease of use and obtainability will make it a natural choice for both those homeowners that would never own a gun as well as a must-have add-on to any gun enthusiast's firearms collection.
