

Coda Octopus Acquires Colmek Systems Engineering

For the fiscal year ending October 31, 2006, Colmek's unaudited results of operations generated contract revenues of approximately \$2.8 million and operating income, adjusted for non-cash expenses, such as share-based remuneration, depreciation and amortization of approximately \$230,000.
