

## BioCorRx, Inc. and Start Fresh Featured on MSNBC, SAMHSA and NIAAA Endorse Medication for Treatment of Alcohol Abuse Disorders

The panel's findings showed drugs such as Naltrexone, the FDA approved pharmaceutical used in the specially formulated implant that is part of the Start Fresh Program, to be effective in the treatment of alcohol abuse as well as managing relapse.

"We are pleased to see medication-assisted treatment, especially when it comes to Naltrexone, getting the attention it deserves that has been long overdue.
