McCartney to host weekly "fireside chats"

NEW YORK, Feb. 5 /PRNewswire-FirstCall/ --SIRIUS XM Radio (Nasdaq: SIRI) announced today that it will launch a limited-run channel devoted to the music of Paul McCartney, in celebration of his new critically-acclaimed album recorded under the guise of his alter ego, The Fireman. *Paul McCartney's Fireman Radio* will premiere on Valentine's Day, February 14 and will air through Friday, March 13 on The Bridge, SIRIUS channel 33 and XM channel 27. The channel will feature a rare in-depth and revealing interview with Paul McCartney. During the interview, the legendary artist will share his inspiration behind his secret Fireman projects.
