Explanatory Note

Sirius XM Radio LLC ("Radio") is furnishing the following information for the quarterly period ended September 30, 2025 in order to comply with the reporting obligations in the indentures governing its 3.125% Senior Notes due 2026, 5.00% Senior Notes due 2027, 4.00% Senior Notes due 2028, 5.50% Senior Notes due 2029, 4.125% Senior Notes due 2030 and 3.875% Senior Notes due 2031. Before making any investment decisions in Radio or Sirius XM Holdings Inc. ("Holdings"), investors should read the following information in conjunction with Holdings' Quarterly Report on Form 10-Q for the quarterly period ended September 30, 2025 (the "Quarterly Report") and Holdings' other reports available through the Securities and Exchange Commission Website at www.sec.gov and our website at www.siriusxm.com, and with Radio's other information available through our website. Radio is a wholly-owned subsidiary of Holdings and Holdings has no operations independent of Radio. Capitalized terms used herein but not defined shall have the meaning set forth in the Quarterly Report.
