(1) Chimera Investment Corporation ("CIM") is a real estate investment trust ("REIT") within the meaning of Sections 856 through 860 of the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder (the "Code"). In accordance with the Code, dividends declared by a REIT during the last three months of a calendar year (and payable to shareholders of record on a specified date in such month), but which are actually paid during January of the following calendar year, are considered paid on December 31 of the calendar year in which the dividends were declared to the extent of the REIT's distributable earnings and profits. The fourth quarter 2020 common stock distribution payable January 29, 2021 to common stockholders of record on December 30, 2020 is treated as received by such common stockholders in 2021.

Shareholders should review the tax statements received from their brokerage firms, transfer agents or other institutions to confirm the dividend distribution information reported in those statements conforms to the information reported here. Shareholders should consult their tax advisors to determine their tax treatment of any dividend distributions received from CIM.
