

## Jushi Announces the Beginning of Adult-Use Cannabis Sales at its Sauget, Illinois Dispensary

Dispensary Will Offer Both Medical and Adult-Use Cannabis Products

BOCA RATON, Fla., March 2, 2020 /CNW/ --Jushi Holdings Inc. ("Jushi" or the "Company") (CSE: JUSH) (OTCXQ: JUSHF), a globally-focused, multi-state cannabis and hemp operator, today announced that one of its two newly acquired Illinois dispensaries, currently operating as The Green Solution and transitioning to the Company's BEYOND/HELLO brand later this year, will open for adult-use cannabis sales today, March 2nd.

Jim Cacioppo, Chairman and Chief Executive Officer of Jushi, said, "Following the successful launch of legal adult-use cannabis sales in January, we are very excited to begin serving adult-use customers at our newly acquired Sauget dispensary beginning today, March 2nd. Illinois represents a very attractive market for the Company, and by expanding our product offering to include adult-use cannabis products, we further solidify our position in this fast growing market. We look forward to providing further announcements as we continue to strategically establish our footprint throughout the state."

Sauget is part of the "Metro East" area of Illinois (Eastern St. Louis suburbs in Illinois) with a population of 702,597 according to the U.S. Census. The region is considered the second largest urban area of Illinois and St. Clair County, where Sauget is located, has a population of 261,059 according to U.S. Census. The area is known for its high traffic due to its proximity to restaurants, bars and nightlife. The current dispensary location is on the same commerce park as GCS Ballpark, home to the Gateway Grizzlies, a professional baseball team in the Frontier League.

The dispensary, located at 2021 Goose Lake Road, Sauget, IL 62206, will be open from 9 a.m. – 7 p.m. Monday through Saturday and closed on Sunday, offering both medical and adult-use cannabis and cannabis products.

Access from Interstate 255: Mousette Lane (Exit 15). From south (JB Bridge/Cahokia) turn left; From north (HWY 15) turn right. Turn left to Goose Lake Road and turn right onto Grizzlie Bear Boulevard. Customers are asked to park within the roped off area designated for the store's adult-use customers.

From Route 3: Follow signs to St. Louis Downtown Airport/Sauget Business Park. Turn right onto Goose Lake Road. Turn right onto Grizzlie Bear Boulevard. Park within the roped off area designated for the store's adult-use customers.
