14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► On September 14, 2019, Kimco Realty Corporation ("Kimco") redeemed all 7,000 shares of its issued and outstanding 5.625% Class K Cumulative Redeemable Preferred Stock (the "Class K Preferred Stock") and 7,000,000 depository shares representing the Class K Preferred Stock (the "Class K Depository Shares"). The Class K Preferred Stock was redeemed at the redemption price of \$25,000.00 per share, plus \$230.468 in accrued and unpaid dividends on each share, and the Class K Depository Shares were redeemed at the redemption price of \$25.00 per depository share, plus \$0.23047 in accrued and unpaid dividends on each share.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► The shareholder will generally recognize gain or loss equal to the difference between the redemption price of \$25,000.00 and \$25.00 per share of the Class K Preferred Stock and Class K Depository Shares, respectively, and the shareholder's tax basis in the redeemed shares. Shareholders should consult their tax advisor for treatment to the extent they actually own or are treated as owning, as a result of constructive ownership rules under the tax code, other outstanding shares of Kimco.
